4. Details of our assessment

Permit condition 2.4.1 requires that the following Improvement Condition (IC), specified in schedule 1 table S1.3, is completed by the date stated in table S1.3 (04/06/23):

Improvement Condition 11

The Operator shall submit to Natural Resources Wales an updated written procedure following additional investigatory work describing how they intend to meet the following BAT requirements in accordance with the requirements specified within:

- BAT Conclusion 9 of the Food, Drink and Milk Industries BRef Document (EU 2019) – In order to prevent emissions of ozone depleting substances and of substances with a high global warming potential from cooling and freezing, BAT is to use refrigerants without ozone depletion potential and with a low global warming potential

The report should include but not limited to

- a review of the use of the current refrigerant as to whether it meets the BAT requirements as specified above and;
- a feasibility study and implementation plan (if appropriate) regarding the replacement of the current refrigerant with one with a lower global warming potential and no ozone depletion potential.

Suitable alternatives include but not limited to ammonia, water and carbon dioxide.

The report shall be submitted to Natural Resources Wales by the date specified for review. Natural Resources Wales will review the report to determine if the above BAT requirements have been achieved.

The operator has not provided a response to Natural Resources Wales in relation to Improvement Condition 11. This was due on 04/06/23. NRW considers this a breach of permit condition 2.4.1- IR2E-Improvement Programme--C3.

Action 1- Complete Improvement Condition 11 as specified in table S1.3. Due 08/09/23.
