4. Details of our assessment

Angharad Clark and Elaine Gunstone attended site and were shown round by Dan Kelly. As previously discussed with the operator, Mathew Roderick, NRW have received a

number of odour complaints about the site. No odour could be detected off site at the time of inspection however, there were a large number of seagulls feeding off the large volume of mixed waste stored next to the shed. Dan Kelly pointed out that a Hawk sound box had been installed that is motion activated to scare off the seagulls.

On 21st July 2023, 10:00, Angharad Clark returned to the site following numerous odour complaints received by NRW. No odour could be detected off site at the time of inspection. Mathew Roderick has also received complaints of odour but stated that odour is only an issue when the waste is being moved. NRW's Incident Call Centre (ICC) are meant to email Mathew Roderick when we receive odour complaints so that he can monitor operations and determine what might be causing the issue. He has not been receiving these emails. Angharad Clark has contacted ICC to re-issue the request for emails to be sent to Mathew Roderick. 21/07/23.

Mathew Roderick and Angharad Clark discussed various operational changes that could minimise the risk of odour escaping the site. Mathew Roderick has agreed to remove the mixed waste currently being stored outside on the impermeable pavement adjacent to the shed and will minimise further storage of mixed waste outside. A timescale of two months has been agreed as reasonable to carry out this work.

ACTION: Remove mixed waste currently stored outside and minimise further storage of mixed waste outside by 22nd September 2023.
