4. Details of our assessment

This report details the site visit made on the 20th July 2023 to Windsor Waste Management Limited located at Chapel Farm Industrial Estate, Cwmcarn, NP11 7BH, permit number, EPR-AB3190CN. NRW (Natural Resources Wales) Officer Greg GARDNER attended the Windsor Waste Management Limited site for an unannounced routine site inspection at 08:45am where I met with Mr. Shaun CASE (Site Manager). The weather was dry, bright, and reasonably warm which it had also been the previous day.

PERMIT BREACHES / ACTIONS

No permit breaches / actions have been identified during this site inspection.

GENERAL OBSERVATIONS

Site drainage was assessed during the site inspection with no issues identified. Any run off enters the nearby surface water drain which then passes into the industrial estates site interceptor. Housekeeping was in good working in order with no loose debris present and all waste(s) were stored securely within the sealed containers.

Empty skips were stored outside of the permitted boundary and were of no concern. There were no offensive odours and / or excessive noises within the permitted and surrounding area witnessed by Officer GARDNER during the site inspection. Site security fencing had been replaced since the last site inspection (CAR_NRW0040113) and was in good working order / condition.

WASTE RETURN SUBMISSIONS

Windsor Waste Management Limited are currently up to date with all of their waste return data to NRW. For quarter 2, 2023 (April - June) 177.92 tonnes of waste was accepted and 159.71 tonnes of waste was removed.
