4. Details of our assessment

Officers Chris Burge and Geraint Harris attend of Maindiff Court Farm, Abergavenny to complete a routine pre planned compliance inspection of the environmental permit EPR-HB3597TC. The weather was warm and dry at the time of the inspection

Site Activities

The site was operational at the time of the inspection with operatives conducting routine site activity including the screening of compost. Waste on site consisted of green/garden waste and a very small fraction of general waste which had been removed as contamination from incoming green waste. The PAS100 certified compost produced on site was inspected and appeared to be of a very high quality. The most recent PAS100 certification was available for inspection.

Site Infrastructure

Both the upper and lower yards of the site benefitted from an impermeable concrete surface which appeared to be in very good condition. Stockpiles of material were contained either with concrete block walling or earth bunding. No issues with site infrastructure or drainage were observed. It was noted that a new weighbridge had recently been installed on site.

Site Management

The composting process on site was clearly very well managed with distinct zones for each stage. Each batch of compost was clearly labelled and segregated on two yards on site. Site operatives were continuously checking and hand-picking for any contamination within the compost batches.

The Technically Competent Manager (TCM) for the site Mr Lewis evidenced an up to date and suitable certificate of continuing competency during the inspection.

Summary

The site was in good condition and no permit breaches were identified during this inspection. Thank you for taking time to show officers around the site and to discuss your activities.
