4. Details of our assessment

Form W1, Emissions to the Estuary for 1st April to 30th June 2023, was received on 26th July 2023. All parameters, except formaldehyde, were within their respective emission limit values (ELV).

The ELV for formaldehyde was exceeded in the composite sample for the week ending 8th June 2023. The measured value was 12.3mg/L; the ELV is 10mg/L. A Schedule 5 Notification, Part A, was submitted on 9th June 2023. Solutia are conducting a detailed investigation as the formaldehyde is thought to originate from another operator on site whose effluent is treated in Solutia's effluent treatment plant. Results should be available shortly.

Natural Resources Wales will decide what enforcement action to take once the Part B Notification has been received and these results, and any remedial actions, have been discussed with Solutia. The report is accepted.
