SC1: The ELV for the pH of the scrubber liquor is ≥ 8.5 . The reported pH value is 9.0.

SC2: The ELV for the pH of the scrubber liquor is ≤ 5 . The reported pH value is 3.5.

SC3: The ELV for the pH of the scrubber liquor is ≥ 10 . The reported pH value is 10.2.
