Q1 2023 Monitoring Returns**Releases to water - Water1**

The returns for reporting of sampling and analysis of emissions to water (other than sewer) for the period Q1 2023 were submitted on 28 April 2023.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Based on the reports submitted by the operator, the emissions at the monitoring point W1 appear **compliant** with the specified emission limits over the Q1 reporting period.
