This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q1 (1 January - 31 March) 2023 monitoring returns by Pembroke Power Station for activities at West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit number EPR/DP3333TA.

Q1 2023 Monitoring Returns

Releases to water - Water 1 (10/11/11)

The returns for reporting of sampling and analysis of emissions to water (other than sewer) for Q1 2023 - were submitted on 19 April 2023.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Based on the reports submitted by the operator, the emissions at the monitoring points appear **compliant** with the specified emission limits over the Q1 reporting period.

Releases to air - IED/LCPBREF CON2 (Gas turbines)

This data was submitted on 14 April 2023 for LCP286, LCP382, LCP383, LCP384, and LCP385.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Emissions at the monitoring points for Nitrous Oxide (NO_x) and Carbon Monoxide (CO) appear **compliant** with the site's specified emission limits over the Q1 reporting period.
