## 4. Details of our assessment

On the 12 June 2023 you notified us by telephone and via a Self-Reporting Watpol that the inlet flow meter controlling the inlet penstock was reading incorrectly and had closed the inlet penstock not allowing full flow to treatment. Flows entered the storm tanks and were then discharged to Brandy Cove.

Condition 2.3.2 of your Environmental Permit specified the following:

(a) The discharge shall only occur when and only for as long as:

(i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt

(b) Storm storage must be fully utilised before a discharge occurs. It shall only fill when the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt and shall be emptied and its contents returned to the continuation flow as soon as reasonably practicable. The minimum off-line storm storage required is specified in table S3.3.

I believe you have breached this permit condition by discharging sewage to the storm tanks and then to Brandy Cove when the required flows passed forward were not being met.

This breach is in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.
