4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) following the submission of the Q2 Monitoring Returns.

Q2 Monitoring Returns (April to June 2023) - Emissions to Water

The Q2 Returns for April, May and June were submitted on 29/05/23, 27/06/23 and 28/07/23 respectively. Submissions were in accordance with Condition 4.2.3 of the Permit.

- April 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- May 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- June 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

Improvement Conditions (IC)

IC8: The Operator provided an inventory summarising the use of current refrigerants at the Installation on 26 June 2023. A feasibility study and implementation plan to support the requirements of BAT Conclusion 9 is to be provided by **15 December 2023**.

Recommendations and Actions

A number of actions and recommendations were identified in the previous CAR (Ref: NRW0041875). For completeness the status of each action is summarised below.

- **ACTION:** Investigate the root cause of the BOD breach and report findings to NRW by **31 August 2023**.
- Provide NRW with a programme summarising the proposed trial dates and durations and the anticipated implementation dates for mitigation technology to minimise the risk of future Ammonia and Phosphate breaches. **An improvement programme was provided to NRW on 28 June 2023.**
- As previously advised, a permit variation must be in place prior to the new boiler being operated. It is recommended that a permit variation application for the new boiler be submitted at the earliest opportunity to minimise any delay in operating the boiler.
