Tarmac Trading Limited

Site Description

The main purpose of the Tarmac Trading Limited (Tarmac) activities at the Port Talbot installation are to serve the Tata Steel UK Limited (TSUK) steelworks processes (EPR/ BL7108IM).

These activities are directly associated with iron and steel production and include slag handling and granulation. Tarmac granulates, crushes and screens slag from the blast furnaces and weathers, crushes and screens de-metallised slag from the steel (Basic Oxygen Steel) plant.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

- Quarter 2 (Q2) April to June 2023 Monitoring Returns

Compliance Assessment

1. Q2 2023 Monitoring Returns

Tarmac submitted the Q2 2023 monitoring returns on the 10th July 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.2).

The required operational parameters were submitted including Cooling Water pH and the Blast Furnace Slag figures. Granulation rates were consistent with previous monitoring periods; with approximately 81% of the liquid slag granulated.
