Dear Mr Tierney

Thank you for your email and the additional information.

It's clear that the proposed investigations can avoid the recorded historic assets and we agree with your conclusion. Ideally, an archaeologist would undertake a walkover survey of the area to assess potential for unrecorded archaeological deposits to be affected, but at this stage the work looks relatively low impact so this may not be warranted.

Our recommendation for a full DBA was to provide early mitigation addressing the potential impact of the completed coastal defence scheme, rather than just this preliminary work, on the historic environment. Once details of this are known, a comprehensive study may still be required.
