Unfortunately, we need more information from you on the application before we can continue working on it. The information we require is requested below:

Air Quality Modelling Report

1. Please clarify which air quality modelling file is being submitted with the application as two have been provided in appendix E entitled 'ICT Air quality Modelling report 030423' & ICT Air Quality Modelling report 270223'
2. Submit the Air Quality modelling files in support of the air quality modelling report as clarified in the above.
3. Acidity deposition or in-combination has not been considered in the air quality modelling report or supporting information as part of the screening for protected areas.
4. The screening distances for sensitive ecological receptors differs in the air quality modelling compared to that in the application supporting document. Please clarify what screening distances for the sensitive receptors you are working to. It is considered that 10Km would be acceptable in this instance as an increased screening distance of 15KM is used for:

Site Boundary and Emission Point Plan

6. Please provide a site boundary and emission plan with the exclusion of the proposed phase 3 development. The current submission with the marked hashed area in pink over the emission points and future proposed development cannot be incorporated within the environmental permit.

Water Discharge Assessment

7. Please clarify application supporting document section process water discharge; 4.3.1 refers to Appendix B should this read Appendix F.

Environmental Risk Assessment Report

8. Please clarify under Process Water Discharge refers to calculation and assessment can be found in Appendix B however there is only an appendices C1 to the report. Is this located within Appendix F as 'Appendix B Site Proxy Data'

Containment

9. Further information concerning secondary and tertiary containment is needed particularly around the wastewater treatment plant (please refer to the risk assessments CIRIA guidance C736). It is also not clear if there will be shut off valves on any potential discharge points to the Dee Estuary in the event of an accident or incident within the risk assessment Appendix C.
