On 18/02/2023 NRW were informed of a Run to Waste activity at Pontsticill WTW.

Run to waste post DAF off 1st stage filters @40mld following power dip to re-establish water quality. No chlorine dosing pre 1st stage so no chlorine present during run to waste. Manual samples of ph, alum & turbidity taken and logged onsite. Run to waste commenced at 04:35am and ceased at 05:10am.

Alum: 0.5instrument / 0.2 Manual

Turb: 0.62 Instrument / 0.13 Manual
pH: 6.63 Instrument / 6.31 Manual
