4. Details of our assessment

This Compliance Assessment Report has been produced following an audit of EnviroWales Limited's procedure for the transport of lead furnace slag off site.

The audit was triggered following enquiries made regarding compliance with measures used to prevent the emissions from the transport of lead furnace slag in skips between EnviroWales Limited's Rassau and Tafarnaubach sites.

Following a desk top review of procedure *LOG – SWM – 012* for the '*pecking and movement of ladles and slag bins in the slag area*' a site based audit was undertaken to test compliance with the procedure.

The 23/01/23 audit undertaken showed the procedure *LOG – SWM – 012* is being complied with and therefore that EnviroWales Limited are taking appropriate measures to prevent emissions from skips during their transport between EnviroWales Limited's Rassau and Tafarnaubach sites.
