4. Details of our assessment

On Friday 4th August 2023 NRW officer Chris Burge conducted a route unplanned site inspection at Permit Number KB3835RT Hanson Quarry Machen, Officer Burge met with quarry staff from Hanson.

The weather was warm and dry and the time of the visit.

Hanson staff explained that the site is no longer excepting material nor is any material being processed on site.

All remaining material is going to be moved to another location, at the moment 15 tons per week is being taken from site, however Hanson are looking at other options to move larger loads by train.

The location of the stored material was within the permitted area, just inside the entrance before you get to the reception, pictures attached of material. Housekeeping was in good working in order with no loose debris present and there were no offensive odours and / or excessive noises within the permitted and surrounding area witnessed by Officer BURGE during the site inspection.



ACTION

Category 4 Breach

Waste returns for Quarters 1, 2 and 3 of 2022 need to be submitted by 30th September 2023, a reminder that even if they are zero returned, they still need to be submitted.
