4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 monitoring returns.

Q2 Monitoring Returns

The Q2 monitoring returns were received on 12th July 2023 for discharges from W1 and W2 emission points in compliance with permit condition 4.2.3.

Suspended solids were reported above the emission limit value of 50mg/l as detailed in Schedule 3(b), Table S3.2. A Schedule 5, part A notification was received for this breach of emission limit on 29th June 2023 and part B was submitted on 30th June 2023.

Site investigations found that the glassware within the composite sampler had become clogged with algae and debris resulting in carry over into the sample which was sent off to an external lab. The internal testing regime and control probes all demonstrated that suspended solids were under the Emission Limit Value (ELV) of 50mg/l. A copy of the internal testing has been provided which demonstrated that suspended solids were below the ELV. Increased maintenance and cleaning of the sampler has now been implemented to prevent re-occurrence of this problem.

Score: (IR3A) Surface Water. Permit Condition 3.1.2. Schedule 3(b), Table S3.2. Non-compliance score C3

Action: No action. Resolution already implemented by operator.

The discharge temperature was over the emission limit but considering the uncertainty factor of 0.5°C there was no breach of the ELV. However, this is a recurring issue with discharge temperatures being at or just above the ELV.

Action: As highlighted in the previous CAR form (NRW0042051) Investigate potential methodologies, process changes or plant alterations to maintain consistent compliance with the temperature ELV.

All other reported parameters were in compliance with the ELV's applied by Permit Condition 3.3.1, Schedule 3(b), Table S3.2
