4. Details of our assessment

Withyhedge Landfill

Resources Management (UK) Limited (RML) operates Withyhedge Landfill in accordance with Permit MP3330WP.

The site is a non-hazardous landfill that covers approximately 53 hectares and is managed in two phases. Phase 1 operated on a dilute and disperse basis; accepting waste from 1985 until its closure in 2006. Phase 2 is the current active section of the Site.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

1. Quarter 2 (Q2) April to June 2023 Monitoring Returns

Compliance Assessment

1. **Q2 2023 Monitoring Returns**

The operator submitted the Q2 2023 monitoring returns on the 25th July 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

Leachate Monitoring

A total of 3427.12 tonnes of leachate were removed off-site during Q2 2023.

Leachate level monitoring was undertaken to the frequency required by the permit (monthly/weekly). Leachate levels in all wells were compliant throughout the monitoring period, with no breach of the 1m limit recorded.

The total leachate volume extracted from boreholes LE1 – LE6 was lower than the minimal monthly limit of 106 m³/month. While the low leachate extraction reflects the levels of leachate in the wells, the site is potentially in breach of permit condition 2.8.1.

Groundwater Monitoring

Over the reporting period, the required groundwater monitoring was undertaken, with no breaches of the trigger levels recorded.

Groundwater level monitoring was undertaken to the frequency required by the permit (monthly).

Surface Water Monitoring

The required surface water monitoring for the quarter was undertaken and the relevant data submitted.

The samples recovered at emission point D1 were within the permitted limits.

Landfill Gas Monitoring

Fortnightly monitoring of the gas collection wells was undertaken, in compliance with Table S4.8 of the Permit.

Monitoring of the perimeter boreholes was undertaken to the frequency required by the permit (monthly). No exceedances of the emission limits listed within the permit were recorded.

Access constraints associated with the development of the landfill prevented the monitoring of BH16 and BH17 throughout June 2023.

The required monitoring of the engines (NO_x and CO) was undertaken during the monitoring period, in accordance with table S4.2 of the permit.
