4. Details of our assessment

Actions listed to bring sampling point to functionality:

- The first being the walk way to the sampling point is very overgrown and could do with cutting back to have a hard standing surface to be safely walked on (the walkway area circled in the first picture).
- Next being the sampling point chamber grate was overgrown with ivy, making the grate hard to remove to view the chamber. Could the ivy be cleared from this grate also?
- Lastly I would suggest having a small liftable hatch cut in to the sampling point main grate to allow for a sampling bucket to be lowered in without having to try and lift the

whole grate.

These actions were sent in an email also. Email confirmation from Mark Harvey showing these works have been approved and are already in motion. We are to be informed of when the works are complete.
