4. Details of our assessment

WARNING

Breach of permit Condition 6.1 - maximum annual abstraction of **909,200m3**.

On the 5th May 2023, BAE contacted NRW to admit over-abstracting water from the Berthin Brook during the period of January 2021 to December 2022. Records were submitted to evidence the breach along with an explanation and future prevention methods.

A persistent over-abstraction greater than 25% is classed as a Category 2 breach of permit conditions.

BAE have persistently (during 2021 and 2022) over-abstracted leading to a 31.43% increase of your annual limit of 909,200m3.

Our enforcement response in this instance is a **WARNING**.

Please ensure measures are taken to prevent **any** future permit breaches. I appreciate the works to prevent any leaks are on-going and that a new recording database has been set-up, however please be aware that should any further license breaches occur NRW may escalate any future enforcement response.
