4. Details of our assessment

This report details the site visit made on the 27 July 2023 to D&E Scrap Metal LTD, permit reference number EPR-BB3290CW. Officers Carla CURTIS and Jodie BASKERVILLE attended site at Adelaide St, Crindau for an unannounced site inspection at around 14:00. At the time of inspection, the weather was warm and sunny.

GENERAL OBSERVATIONS - Officers were accompanied around the site by David EAGLE (permit holder) and the following observations were made.

The depollution activity is undertaken by a suction device which punctures the tanks and sucks out any hazardous waste, which is then stored in a suitable container before being removed by an appropriately authorised contractor. See photo 1

The general housekeeping of the site was of a good standard, and the infrastructure on site appeared to be in good order with no cause for concern.

The site also operates under S1, S2 and T9 exemptions primarily for the treatment of scrap metal. Compliance with these will be considered separately. The site's exemption registration expires on 26/07/2024. The operator is aware of the upcoming changes to exemptions which may affect operations on site.

SITE INFRASTRUCTURE AND DRAINAGE - The impermeable surface appeared to be in fair condition but was advised to undertake regular checks of the surface and ensure that any damage which may affect the integrity of it is repaired. Site drainage is via an interceptor which is emptied biannually. See photo 2

TECHNICAL COMPETENCY - Tania EAGLE is the TCM for the site.

WASTE RETURN SUBMISSIONS - The maximum waste quantity that can be accepted by the site is 5,000 tonnes per year. Responsibility for waste returns lies with Tania Eagle. Information contained within the waste returns appears to be up to date and within permit limits. The waste return for Q2 2023 was submitted on 06/07/23, Waste codes accepted: 160104 totalling 46 tonnes. 46 tonnes were removed from the site as waste, coded as 160104. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.

PERMIT COMPLIANCE AND BREACHES - No permit non-compliances were identified on this visit and thus no breaches have been scored.
