4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 monitoring returns.

Monitoring Returns Air

The Q2 monitoring returns were received on 19th July 2023 for discharges from A6, A7 and A15 emission points in compliance with permit condition 4.2.3.

Monitoring returns Water

The Q2 monitoring returns were received on 19th July 2023 for discharges from W2 emission points in compliance with permit condition 4.2.3.

Ammonia was reported as **30.5 mg/l** significantly above the emission limit value (ELV) of 4mg/l as detailed in Schedule 3(b), Table S3.2.

The breach of the ELV for 26/04/2023 at 04:46 hrs has been discussed and scored in Compliance Assessment Form (CAR) **NRW0041958**. Actions with deadlines to complete were also detailed in this CAR form. No further scores will be given in this assessment.

All other reported parameters were in compliance with the ELV's detailed in Permit Condition 3.3.1, Schedule 3(b), Table S3.2.

Waste Returns Q2 2023

Permit Condition 4.2.5 require the operator to submit quarterly waste returns to NRW within 28 days of the close of the preceding quarter. Waste returns for Q2 2023 were received within the stipulated timeframe with no issues identified.
