4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 and biannual monitoring returns in accordance with permit condition 4.2.3 (a)

Q2 Monitoring Returns - Air

The Q2 monitoring returns were received on 27th July 2023 for emissions from A1, A12 and A13 emission points in compliance with the timescales stipulated in permit condition 4.2.3.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.

Q2 Monitoring Returns - Water

The return for water was a 'nil return' as there had been no discharges during this reporting period.

Bi-annual monitoring of emissions

The biannual data was also submitted on 27th July 2023 in accordance with permit condition 4.2.

There is missing data for the results of sulphur dioxide and hydrogen chloride but a Schedule 5 Part B was submitted explaining there had been a delay with the lab processing these results. The results were provided on 11/08/2023 and both ELV's were in compliance.

All other reported parameters were all in compliance with the ELV's defined in Schedule 3 table S3.1.

Q2 Schedule 5 Notifications

1) As per permit condition 4.3 (b) Natural Resources Wales received notification on 4th July 2023 that due to an intermittent power failure no data was recorded for A1 and A12 particulate emissions from 27/06/23 at 14:35 hrs until 4th July at 11:35 hrs.

2) A Schedule 5 notification was received on 10th July 2023 for emissions to air. Due to heavy rain on 8th July, when the factory was not running, a power disruption occurred. Following the power disruption, the particulate measurements were very high even though the factory was not operating. Following investigations, the probe was cleaned and particulate emissions returned to normal.

As both notifications relate to power failures outside of your control no scores will be applied on this occasion.
