4. Details of our assessment

This site visit was the final inspection undertaken by Linda Warrick as part of the

commissioning and validation testing of the ECOSTRYLE Microwave plant. The plant has been installed on site since the March 2023. Several visits have been conducted over the last few months. Efficacy testing was undertaken on the 5th and 6th of June. The bioaerosol monitoring was conducted on the 8th of June.

The final commissioning and validation report was received on the 29th of June 2023. This was reviewed by Linda Warrick and authorisation for the plant to move into the routine monitoring phase was granted on the 26th of July 2023.

The plant started operating on the 31st of July 2023.

The plant is currently operating for demonstrative purposes with a maximum running time of 36 hrs. Continuous operating will require further assessment of the levels of bioaerosol emitted by the plant along with the assessment of a potential need for a HEPA filter fitted to the Hopper feed part of the process.

Ongoing efficacy testing will be conducted every 2 weeks for the first 6 months and then that will move to every two months as detailed in Annex 2 of EPR 5.07.
