4. Details of our assessment

This CAR form is being issued as NRW have received a Spill Frequency Trigger Exceedance Notification by e-mail from Dwr Cymru on the 25th of July, as a retrospective notification, as the exceedance date was the 16th of January 2023.

The guidance for trigger exceedances requires that such notifications be sent to NRW within 4 weeks of the exceedance. This didn't happen on this occasion and according to the specific permit conditions for this site an investigation report should have been sent to NRW within 3 months of the exceedance. As the notification wasn't received until July this requirement hasn't been met. As such, this is being recorded as a permit breach. The CAR form is dated the 17th of April 2023 as the investigation report should have been with us by then.

Please supply an investigation report as soon as possible. If the deadline stipulated in this CAR form is unachievable, please supply us with a timescale for delivery of the report.
