4. Details of our assessment

A routine announced site inspection was carried out of the Pembrey Circuit bund site operated by Gower Recycling Ltd under permit EPR-MB3393HW. The permit was issued in 2015 as a Standard Rules SR2010 No. 7 permit.

David Ellar and Elaine Gunstone of NRW carried out the site visit. We were met on site by

Gower Recycling representative Mark Jones and Phil Davies (Pembrey Race Track). The purpose of the visit was to see if waste was still being accepted under the permit.

The weather was fine and dry.

In a previous CAR (CAR_NRW0037003) dated 14/10/2020 it was noted that a review of waste duty of care notes that incoming waste to site had exceeded the 50,000 tonne limit of the SR permit and Gower Recycling Ltd must cease taking waste material into the site under the permit. No evidence that waste had been brought into site since October 2020 under the SR Permit was found. The area where waste had been deposited was fully grassed over and the processing yard was shut with no sign of any waste operation there. This was confirmed by Mark Jones and Phil Davies.

No breaches of permit were observed during the visit.

Other areas of discussion:

Permit surrender:

NRW officers discussed with Mark Jones that the the permit had not been used since October 2020 and due the limit being reached it could not be used. Gower Recycling were still paying subsistence fees as the permit was still active. Options for permit surrender were given back in 2020 but they were not actioned on. Gower Recycling Ltd were advised that they should look into permit surrender options.

Miscoded waste:

It was noted in a Previous CAR that NRW were concerned that a significant quantity of miscoded waste had been received at the site between March 2018 and July 2020, more information was given to Mark Jones about this and how it may affect future land use or permit surrender. This issue will be communicated further in separate correspondence.
