**4. Details of our assessment**

This Compliance Assessment Report follows an unannounced off-site amenity assessment around the perimeter of the site.

The weather was sunny and there was very little wind for the duration of the off-site assessment.

Observations were carried out between 16:00hrs and 19:00hrs around the perimeter of the site. No significant odours were detected.

At 19:00hrs, landfilling operations had ceased and plant machinery was turned off. There was no activity on the active cell but the site gates were still open. There were a number of birds present on site. Daily cover had been applied to the waste mass but in some areas the layer of cover was thin and patchy with waste visible. There was also a small pile of waste which had not been incorporated into the cell.

Officers observed birds picking at the uncovered waste and removing waste off-site. The Operator has management systems in place for the handling and disposal of waste, prevention and control of pests (including birds) and to reduce the risk of off-site litter. However, at the time of this inspection, 19:00hrs, it was clear that aspects of the site management systems had not been followed as the application of daily covering material was not adequate. Natural Resources Wales considers this a breach of permit condition 1.1.1-IRIA-General Management-C3.

Action 1: At the end of waste tipping activities, ensure all waste is incorporated into the cell and that adequate daily cover is applied to prevent scavenging by pests and off-site litter.
