**WHEREAS** the **ENVIRONMENT AGENCY** in pursuance of its powers under Schedule 10 to the Water Resources Act 1991 granted on 17<sup>th</sup> day of July 1987 CG0110901 permitting the discharge of **TREATED SEWAGE EFFLUENT**

**FROM: LLANFACHRETH STW**

**AT: SH 75370 22340**

**TO: Afon Y Llan**

**NOTICE IS HEREBY** given by the **ENVIRONMENT AGENCY** that, following the publication of the PR04 agreed programme for sewerage undertakers in England and Wales, and in pursuance of its powers under the paragraph 7(2) of Schedule 10 to the Water Resources Act 1991, the said Consent is **MODIFIED** as follows:

A. Substitution of condition 7 attached to CG0110901 by the following new condition:

**7. Treated Sewage Effluent:**

The limits set out below may be exceeded where, in any series of samples taken in the period of 12 months ending on the date of the discharge, as listed in column 1 of Annex 1 attached to this consent no more than the relevant number of samples, as listed in Column 2 of the said Annex, exceeds the applicable limit for that determinant at the time when a sample is taken.

- (i) The biological oxygen demand (ATU) in 5 days at 20°C shall not exceed 40 milligrams per litre
- (ii) The suspended solids dried at 105°C shall not exceed 60 milligrams per litre.
- (iii) The ammonical nitrogen (expressed as N) shall not exceed 35 milligrams per litre.

Subject to the provisions of Paragraphs 7 and 8 of Schedule 10 to the Water Resources Act 1991, no notice shall be served by the Agency, which alters the effect of modifications made by this notice, without the agreement in writing of the Consent Holder, during a period of 4 years from the date this notice is served.
