4. Details of our assessment

SURFACE WATER PERIMETER DISCHARGE INSPECTION

The stream running adjacent to the site was inspected at the site perimeter on the 31st July 2023.

This had historically been a recipient of pollution loading/contamination. During the time of inspection there was no evidence of pollution and no 'sewage fungus' present on the stream bed.
