4. Details of our assessment

On Tuesday the 25th of May 2021 waste regulation officer Boguslaw Pierzchala and senior waste regulation officer Steven White attended the site.

This was an unannounced inspection. Sean and Sarah McGilloway were on site during the visit but did not accompany officers during the inspection.

Specified by Permit; Management System and operating procedures, Containment of stored materials

The front yard appeared very tidy and well-maintained. Vehicle engines were stored indoors and the de-pollution area was clean with no apparent spills. All waste liquids -oils and fluids were stored indoors in sealed and secure containers.

End-of-life vehicles were stacked up 2 or 3 high in the main yard. A number of vehicles were checked and a small amount of liquid was found; however, the officers would not be able to say whether it was screen wash or rain water.

Tyres were stored very neatly underneath an archway.

There were some vehicles stacked on top of each other adjacent to Greenfield brook. One of the vehicles appeared to be leaning towards the brook. Ms McGilloway was advised not to stack up the vehicles in this particular area as there is a risk of them falling into the stream.

Management System and operating procedures

WAMITAB qualification and TCM coverage was discussed. Ms McGilloway is due to sit her test and for the time being an external TCM is looking after the site.

Waste returns

Waste returns were discussed as there appeared to be a typing error in the tonnage accepted. This will be taken into consideration when completing future returns.
