4. Details of our assessment

This Compliance Assessment Report (CAR) follows a site inspection to confirm the removal of the HDU and associated infrastructure.

A number of the activities listed in Table S.1.1 are no longer operational and the associated infrastructure has been removed. The only activities that remain operational are:

A5	Washing of clinical waste containers.	Washing of containers used for clinical waste storage.	No limit on capacity.
A7	D15: Temporary storage of waste pending any of the operations numbered R1 to R12 (excluding temporary storage, pending collection, on the site where it is produced). As a result of the removal of the HDU, NRW agree that the monitoring identified in Table S3.1 *Point source emissions to air* and Table S3.4 *Process monitoring requirements* are no longer required.

All other permit conditions remain applicable.

It should be noted that all reporting requirements (with the exception of those relating to Tables S3.1 and S3.4) remain and nil returns should be submitted where applicable.

Operational procedures should be updated to reflect the changes at the site.

The Operator have stated that at this stage they do not wish to part surrender or vary the permit.

Should the Operator wish to recommence any of the activities in Table S1.1 that have currently been removed, prior discussion with NRW is needed to ensure that these are compliant with all relevant legislation at the time, including the relevant BAT requirements.

This CAR should be kept with the Permit for future reference.

Nb: As agreed with the Operator, a separate CAR will be issued to cover other aspects of the site inspection.
