4. Details of our assessment

Routine site inspection of the Package Treatment Plant serving the Raglan Highways Depot, Station Road, Raglan, by Environment Officer Peter Jones and Edward Cox. Visiting Environment Officer signed in at the site reception, a member of staff showed the officers the location of the treatment plant.

Weather: Dry and bright.

A visual inspection was made of the package treatment plant. The plant was operating and there were no odours or indications that the plant was not operating as designed. The discharge point was checked, the outlet was not visible due to the vegetation growth but

water course was clear and there was no indication the discharge was having a negative impact on the water course.

Please ensure you continue to service the treatment plant on a regular basis to reduce the pollution risk from the site.
