4. Details of our assessment

Routine site inspection of oil interceptors serving the Raglan Highways Depot, Station Road, Raglan, by Environment Officer Peter Jones and Edward Cox. Visiting Environment Officer signed in at the site reception, a member of staff then showed the officers the location of the interceptor.

Weather: Dry and bright.

The hard standing area was well maintained and the surface water drains were clear of any obstructions. The interceptor looked to be operating as designed and there was no visible sign of oil being discharged to the Nant y Wilcae.

Please ensure you continue to service the separator on a regular basis to reduce the

pollution risk form the site.
