Natural Resources Wales officer Shaun Rees met with Mr & Mrs Evans to carry out a routine inspection for the site on the 22nd August 2023. Thank you for your time during the visit.

Inspection and Maintenance

Emissions and Monitoring (Drainage management)

Drainage channels to be installed at the edge of concrete yard directly in front of gable end fans on all three poultry houses to allow any contaminated rainwater to be collected and contained as per CoAPR. Please ensure that all drainage plans are updated with newly installed drainage channels and storage tanks. Please provide photographic evidence of this action by 6th October 2023.

Raw materials containment -

*Storage vessels for foodstuff should be protected from collision damage. This can be achieved by: a bunded area, or careful siting relative to traffic flows with measures such as provision of kerbs or other markers to stop reversing vehicles, or by the use of barriers in more vulnerable locations. Containment should be provided for foodstuff to prevent spillages and minimise waste. Any foodstuff which might flow under the influence of gravity (e.g. liquid feed) should be contained. Containment should consist of siting the store in an area isolated from the surface-water system so that any spillage cannot enter any drainage system
Please provide photographic evidence of this action by 6th October 2023.*
