## 4. Details of our assessment

### Temporary carcass trailer arrangement

NRW has received a letter from the Operator requesting a further time extension for the interim arrangement relating to carcass loading.

The carcass trailer is currently housed within an inflatable building. Dolavs are loaded into a refrigerated trailer which is shunted to the inflatable building, the dolavs are then emptied into the trailer under cover. This operation has been working well.

A permit variation was issued to the Operator on 14/06/2023 which includes an update to the operating techniques. These state that an extension will be built adjacent to the chill building and comprise two loading bays primarily to allow for the loading of waste, including animal by-products, under cover.

In order for the new loading bay building to be constructed the Operator has stated they would have to amend the interim arrangement relating to how dolavs are moved to the inflatable building. The Operator is installing a temporary fabricated tunnel from the chill area to the inflatable building in order for the movement of dolavs to remain under cover. However, there has been a delay in the manufacturing of this tunnel and therefore construction works on the new building cannot commence.

NRW agree to the continued use of the inflatable building for the storage of carcasses for a further 3 months, until 31 December 2023, in order to facilitate the construction of the new building.

NRW will consider its enforcement position if there are any further delays to this project.
