4. Details of our assessment

12/05/2023 Officers visited site with an operative on behalf of Mike Jones MEI Supervisor, as a part of the 2023 Pre Season Bathing Water checks. At the time of inspection the site appeared to be operating well with no noted instances of non compliance with permit BW0202801.

It was noted that the maintenance for the storm screens for this asset is performed by the Afan WWTW team.

In order to satisfy points raised during the inspection and as a follow up, officers request that Dŵr Cymru provide the following;

1. A maintenance record for the site covering the last five years.
2. Details of the status of all on site pumps and any spares.
3. EDM readings for the operation of this overflow.

The data requested should in both the summary block counting and 15 minute interval formats for a period of two years.

Please provide this information on or before 25/09/2023.
