4. Details of our assessment

12/05/2023 Officers visited site with MEI Supervisor Mike Jones. At the time of inspection officers noted one instance of non compliance with permit BB4025501 which has been listed below. This potentially represents a larger issue for the site which will likely require some future investment.

Non Compliance: Discussions regarding the standard of screening provided at this site have raised concerns about how the screens perform during higher flows. Their design style means that when flows are high it is likely/possible that flow bypasses over the top into the discharge making it non compliant.

Condition(s): 5 (a), (b) & (c)

Action: While officers acknowledge this may be beyond a general compliance fix, they would welcome a wider discussion on the performance of the screens and to consider how they could be improved to reduce the risk of carryover during higher flows with the aim to bring about future improvement.

Officers also require the following additional information;

1. Photographs and/or design schematics of the screening system on site.
2. Five year maintenance records for the site.
3. Details of the status of all on site pumps and any spares.
4. EDM readings for the operation of the overflow.

The data requested should in both the summary block counting and 15 minute interval formats for a period of two years.
