4. Details of our assessment

Routine sample taken by sampling team on 31/07/2023. This sample gave an analysis on suspended solids of 41 mg/l. The permit BM0021001 authorizes a suspended solids limit of 30 mg/l. We contacted Roadchef LTD asking for the permit failure reason and what actions are to be taken going forward. Scott Reece (Head of maintenance) commented;

Further to your letter referenced above dated 10.08.23, we have asked our maintenance provider, Hutchinson Environmental Solutions, to comment, please see below.

“We have reviewed our service records since January 2022. Other parameters on the Permit are well within specification so we don’t believe there is an issue with treatment per se. Footfall through the site has increased considerably as the UK recovers from Covid travel restrictions and more people choosing to holiday in the UK. We will continue to monitor and maintain the system.”
