4. Details of our assessment

On the 3 August 2023 Environment Officers Alex Grabham and Harry Warburton met yourself Stephen Banks (Manager) onsite to check for compliance with permit AN0139701. The weather was dry and sunny during the site visit.

As discussed a sample taken on 6 December 2022 failed numeric conditions for BOD. The results for which are included below:

Parameter	Limit (mg/l)	Result (mg/l)
BOD	20	24
Sld SUS	30	17

However, subsequent samples taken on the 8 February 2023 and 9 May 2023 were back in compliance.

During the visit we inspected the treatment plant which appeared to be in good working order and you stated that the motor and associated equipment had recently been replaced and the system had been cleaned by your contractor. We also inspected the downstream watercourse which appeared clear with no signs of nutrient enrichment from the treatment plant.

We also inspected the maintenance records and noted the recent motor work and transfer notes for the treatment plant.

During our visit no non compliance with the permit was observed.
