4. Details of our assessment

Officer Chris BURGE and Gavin DODD attended Thomas Waste Management Limited to complete a routine, unplanned compliance inspection of the permit EPR-AP3399FR. The weather at the time of the inspection was mild and dry. Officers met with site manager Gareth Thomas and were introduced the site.

Inspection Observations

The site was operational at the time of the inspection and an introduction and tour of the yard was given. All waste types are stored and segregated appropriately within concrete bays or sealed skips within the permitted area

Photograph one shows an example of a storage bay containing waste plastic.



Previous compliance inspections have noted damage to the concrete surface on part of the site where the sorting activities take place. This area has been recently repaired and was in good condition and there is a rolling programme of maintenance at the site.

Construction and demolition wastes are stored in stockpiles on site, both before and following processing. It was noted that these wastes are processed on an ad-hoc basis dependent on supply and demand.

Actions From Previous inspection

1. Remediate SW corner area of site to prevent potential sediment pollution to surface water. Appropriate measures should be taken to ensure that run-off is directed towards the site drains and the interceptor on site.
2. Remove skips containing waste from outside permitted area. Ensure all site activity is contained within permitted area only

It was noted that all the actions from the previous inspection had been completed.

Waste Returns

All waste returns have been submitted on time in line with the permit condition.

Officer Burge has no actions from this site inspection.
