Schedule 4 – Emissions and monitoring

Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells below 2m.

The well data extracted from the schedule 6 report below are all over the 2m permit limit. Taken from the associated CQA plan this well sits 0.38m above the AOD base of the original well, therefore the measurement from this level AOD is valid. However due to the difficulties encountered in retro drilling and silting and the action proposed in Part B of the Schedule notification, the CCS score is consolidated for the 4 breaches into a single score of CCS 3.
