4. Details of our assessment

CAR form issued following receipt of a self report of pollution from Dwr Cymru. This was in relation to a leak from the storm tank at Dolgellau STW. The leak meant that the storm tank discharged before it was full which is contrary to permit condition 2.3.1.

It is noted that a previous CAR form has been issued regarding the same problem at the sewage works in April of this year. A temporary repair had been undertaken at that point in time.

When will a permanent repair be undertaken?

Please note that further problems regarding this storm tank may result in NRW taking a higher level of enforcement action.
