Routine visit on the 23/08/2023. Environmental Officer Alastair Krzyzosiak in attendance. Mrs Roberts, the owner of the property, was present.

The drainage field and adjacent pond/watercourse was assessed and there was no sign of pollution.

Mrs Roberts (current owner) stated that the tank had been recently emptied. The current home owners are not the permit holder. I advised Mrs Roberts to contact the permit holder to arrange for the permit to be transferred.

Please continue to operate the plant as per the manufacturer's instruction and de-sludge

when necessary.
