Routine visit on the 23/08/2023. Environmental Officer Alastair Krzyzosiak in attendance. Nobody was present at the property at the time of the visit.

Called in at the property but nobody was at home. I was able to quickly assess parts of the drainage field, but much of it was under vegetation. No obvious signs of non-compliance with the permit. No further actions required.

Please continue to operate the plant as per the manufacturer's instruction and de-sludge when necessary.
