4. Details of our assessment

This was a prearranged familiarisation visit and routine inspection of the Installation by Natural Resources Wales (NRW) regulating Officers.

A brief introductory meeting was held with Sally Davies and Fiona Montague. Items raised in a previous CAR (NRW0040640) were discussed and followed up on a high-level tour of the facility.

- Procedures for the appropriate management and maintenance of the vehicle washdown area have been provided to NRW and have been implemented. The washdown area was clean and generally silt free
- The roller shutter doors now have signage above each door directing personal to shut the door before loading.
- Spill kit bins now have clear signage and are checked regularly by site staff for any waste.
- Overall, the Installation was ordered and tidy at the time of the visit.

Changes to emission point A7

The Operator confirmed Emission Point A7 is not currently venting externally, but venting internally to the grinder room. It is the view of NRW that the emission point should remain on the permit and continued to be monitored as per permit condition 3.5.1. Any changes must be reported to NRW in writing.

Permit Improvement Conditions (IC)

IC7: The Operator has submitted to NRW a baseline condition report to support the conclusion of IC7 NRW are currently reviewing the report.

IC8: Completed – The Operator confirmed that a waste gas inventory has been included as part of the Environmental Management System since 2018. Wastewater is not generated as part of the permitted process.
