4. Details of our assessment

Arranged follow up inspection following identification of C2 breach of permit on 7th July 2023 highlighted in CAR_NRW0042129. In attendance, Michael Edwards and David Ellar of Natural Resources Wales

accompanied by Christopher Chaney and Rita Vassallo of South West Wood Products.

Waste Storage (C2)

During the previous inspection issues were raised with stack separation distances, not in line with the conditions of the submitted FPMP – 2205B/FPMP v1.5.

It was noted during this inspection significant improvements have been made to the storage of waste wood on site, with a reduction in the stock, an increase in separation distances and a reduction in stack heights complying with the FPMP.



Discussions were had on site with regards to a new secondary export destination for the waste wood that would allow the site to manage the stockpile should issues arise with the Margam plant in the future.

An issue was raised during the inspection due to the storage location of the 'Grade A' wood being stored on the designated quarantine area identified in the FPMP. As discussed on site due to the significant improvements made on site with more available space should an incident occur, the category for this breach is reduced to a **Category 3**, breach of permit **conditions 2.3.1** and **3.5.1**. This score is suspended as it is an

ongoing non-compliance with the FPMP, carried over from the previous inspection.

Action – As discussed on site, you must ensure that the FPMP is complied with and ensure that the quarantine areas remain free of any waste storage. As agreed during the inspection, please provide evidence of this once completed.

EDIT* - *Following the inspection Rita Vassallo has submitted evidence showing the removal of wood from the designated quarantine area (5/9/2023).*
