within 3 months of the trigger breach, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation;

On the 02/06/2023 you sent to us a Trigger Exceedance Notification (TEN) for St Michaels Church CSO. The TEN informed us that, on the 08/05/2023 the number of spills had exceeded the limit of 14 block counted spills.
