4. Details of our assessment

This was a site familiarisation visit for the new NRW regulating officer, Kathryn Bradshaw accompanied by Philip Harper, the previous regulating officer.

The QHSE Manager was the host for the site visit and accompanied us throughout the visit.

The QHSE Manager provided an overview of the site's history and current operations. We were then provided with a comprehensive tour of the facility. The permitted air and water emission points were viewed along with the installation activities. The incoming material bays, oil storage area and finished product storage were inspected, and no issues found.

Discussions were held on the Schedule 5 notifications that had been received and the site confirmed all these issues had now been resolved which included the installation of a new transformer on site and bringing the monitoring forwards to prevent any late submissions.

The HR and CSR Manager joined us later in the visit to explain the company had submitted a permit application for a scrap metal site located on Bryn Lane, Wrexham Industrial Estate and provided an overview of the intended operations for this site and how it links into the wider business.
