4. Details of our assessment

Thankyou for taking the time to show Libby Hughes and Cheryl Griffiths around the site on August 10th.

A number of issues were outstanding from the previous CAR form: **CAR_NRW0040736**

- A new site information board has been installed as required.
- An updated site map was provided to NRW in January this year as requested.

Production has been suspended at Bryn Golau since the beginning of the year, so this visit was primarily to ensure that the site has been decommissioned to a suitable condition which cannot cause damage to the environment to occur, until such a time that decisions are made on the future of the unit. Natural Resources Wales shall be given at least 14 days notice before implementation of any part of the site closure plan.

Following the last crop all potentially polluting substances have been removed from site; the litter was removed, and the wash water was emptied out. The fuel and LPG tanks have been drained. The diverter has been set so that any collected rain water will run off-site

There is still some rubbish collected and stored in the skip which has not yet been removed from site.

Implement a regime for checking the site for safety and security on a regular basis while the site is empty. You should ensure that this is in place by 22nd September, and send a copy of the completed form showing the date and outcome of the first visit to Libby.Hughes@cyfoethnaturiolcymru.gov.uk as evidence. You should ensure that additional checks are carried out if there are any adverse weather events which could impact the site. You are reminded that you must notify NRW in future if any incidents or accidents occur which could affect the environment.
