4. Details of our assessment

Thank you for taking the time to show NRW officers around the site on Thursday the 10th August 2023.

Production has been suspended at Pen Y Fridd since beginning of 2023 which means that this visit was primarily to ensure that the site has been decommissioned to a suitable condition which cannot cause damage to the environment to occur, until such a time that decisions are made on the future plan for the unit. Natural Resources Wales shall be given at least 14 days' notice before implementation of any part of the site closure plan.

Following the last crop, all the wash water was emptied out, the fuel tanks have been drained and the diverter had been set so that any collected rainwater will run off-site. You have also confirmed via email since our visit that the LPG tanks have been emptied.

There is rubbish around the site which needs to be tidied away by putting them into the rubbish skip which has yet to be emptied & removed from the site.

A site checking system should be implemented to improve the site security while the site is not in use and all hazardous materials should be locked away in a safe environment. Please ensure that additional checks are carried out if there are any adverse weather events which could impact the site and notify NRW in future if any incidents or accidents occur which could affect the environment.
